# Master of Philosophy / Doctor of Philosophy

#### Introduction

The Faculty of Graduate Studies (FGS) of the Kotelawala Defence University (KDU) provides a unique opportunity for officers of Tri Services, Public and Private sector with appropriate qualifications to carry out their research in the relevant disciplines with maximum support and guidance from eminent scholars.

Supportive courses are also offered in Research Methodology, Scientific Communication and Statistics to improve their knowledge and facilitate their research work. Further, FGS provides opportunities for the candidates to establish links with local and international scientists via local and international institutes. Postgraduate students are always encouraged to publish their research work in Indexed Journals, Peer reviewed Journals and communicate in local and international research conferences.

#### **GOALS AND OBJECTIVES**

#### **Overall Goal**

A key aspect of FGS at KDU is that postgraduate education is closely linked to research. It provides opportunity to the postgraduate candidates to pursue their research in different disciplines and in interdisciplinary and

multidisciplinary studies. Students learn how to carry out research effectively from research scholars who are actively involved in research, thus enabling students to conduct advanced and creative research themselves.

The overall goal of FGS at KDU is to develop and enhance the capabilities of researchers possessing originality and ingenuity to conduct pioneering research at the frontlines of different disciplines and interdisciplinary & multidisciplinary research.Prepare the postgraduate students to be core members of international and interdisciplinary research projects, and through their research and other activities, meet the needs of the industrial sector and society contributing significantly to the national development.

#### Objectives

To realize the overall goal described above, the FGS has set the following educational objectives for MPhil and PhD degrees.

An MPhil degree will be conferred to those who have completed a minimum two-year period of residence, studied the compulsory subjects, passed the required examinations specified in By-Laws and passed the thesis review and Viva Voce under the guidance of an academic supervisor.

A doctoral degree will be conferred to those who have completed a minimum of three-year period of residence, studied the compulsory subjects passed the required examinations specified in By-Laws, and passed the thesis review and final examinations under the requisite guidance of an academic supervisor.

#### Eligibility Criteria

#### Master of Philosophy

The minimum requirements for registration for MPhil degree programme are:

- A Master's Degree (SLQF L 9/10) in a relevant field from a recognized university; or
- A Bachelor's degree in a relevant field of four-year duration (SLQF L6) with a First or Second Class from a recognized university; or
- A Bachelor's degree in a relevant field of three-year duration (SLQF L5) with a First or Second Class and with a minimum of two-year experience in the relevant field; or



Passed Staff College (psc)/ Logistics Staff Course (lsc) or an equivalent from a local or foreign institution with a minimum of 20 years of service; and Evidence of at least one research publication. This includes journal articles/ conference papers; or

> Any other relevant qualifications R ecommended by the relevant Board of Study, accepted by the Faculty Board, Faculty of Graduate Studies and approved by the Senate

#### **Doctor of Philosophy**

The minimum requirements for registration are:

- An MPhil degree in a relevant field from a recognized university; or
- An approval by the Senate for upgrading from an MPhil to PhD programme; or
- A Bachelor's degree in a relevant field of full-time four-year duration (SLQF L6) with a First Class from a recognized university, and with evidence for adequate experience in research as acceptable to the relevant Board of Study; or
- Any other qualification equivalent to a full-time two-year research degree (SLQF L 11) acceptable to the relevant Board of Study and to the Faculty Board, Faculty of Graduate Studies and approved by the Senate.

#### **Programme Structure**

Total course modules are worth of 14 credits. The program commences by offering the Proposal Writing Techniques in the first month in every weekends on both Saturday and sunday. The students are expected to submit the Research Proposal, and give a proposal presentation within the provisional registration period (2 Years) while attending lectures of other four modules.

#### **Course Syllabus**

The orientation programme offers 4 modules, namely, Proposal Writing Techniques, Introduction to Research Methodology, Scientific Communication, Statistical Techniques for Research. The orientation programme is compulsory for Window 1 candidates and optional for window 2 candidates. Candidates are required to secure 80% attendance to meet the course requirement. While following lectures the candidates are expected to conduct their research project under the guidance of the supervisor.

#### Duration For an MPhil Degree Programme The minimum duration

The minimum duration for the MPhil degree shall be two you years for a full- time candidate and three years for a part time candidate from the date of registration for the degree.

#### The maximum duration

The maximum duration for the MPhil degree shall be five years for a full time candidate and seven years for a part time candidate from the date of registration.

#### **Transfer from MPhil to PhD programme**

Candidate may submit a written request for a transfer from MPhil to PhD after completing at least one year to the Dean through the Head of the relevant department with a recommendation of the supervisor.

On the recommendation of the Head and the FHDC the Dean appoints a panel of reviewers for consideration of the request. Candidate is required to give a presentation to the panel of reviewers showing the progress over last 12 month.

#### Duration for an PhD Degree Programme The minimum duration

The minimum duration for the PhD degree shall be three years for a part time candidate from the date of registration

#### The maximum duration

The maximum duration for the PhD degree be seven years for a full time candidate and nine years for a part time candidate from the date of registration. <sup>C</sup>The purpose of learning is growth, and our minds, unlike our bodies, can continue growing as we continue to live.


