1. INTRODUCTION

The authors should provide complete information asked on the front page of this template. Write an introduction to your research with objectives. Define abbreviations and acronyms the first time they appear in the text.

This document is a live template for the preparation of a manuscript to publish in a volume of KJMS. This KJMS manuscript template is compatible with Microsoft Word 2007 or later. The template is downloadable from the website of the KJMS link (<https://kdu.ac.lk/kjms/>), and the authors can use it to prepare their manuscripts.

The authors can type over different sections of the template doc or cut and paste from another document and then use markup styles. Do not change the font sizes or line spacing to squeeze more text into a limited number of pages. Use italics for emphasis; do not underline. To insert images in Word, position the cursor at the insertion point and either use Insert | Picture | From File or copy the image to the Windows clipboard and then Edit | Paste Special | Picture (with “In Line with the text”).

The pictures and tables are preferable to be at the end of the manuscript in a separate section named ‘Figures’ and ‘Tables’ placed before “References”. The figures and tables may be placed with the regular text also, instead of separate sections, if it is required for better interpretation intent of the content. The editorial team of KJMS’ will do the final formatting of your paper.

2. METHODOLOGY

Formatting the manuscript

KJMS Editorial Team has created this template. The authors can use it with given spacing, font sizes, etc. to format the manuscript for submission to the journal for publishing. The team reserves the right of making alterations and modifications to the template as well as the format of the manuscripts before publishing. Authors are requested to abide by the formatting of this template for submitting their manuscript for publishing in KJMS’ failing which, the content may be rejected without considering it for review

irrespective of the quality and/or relevance of the content. This document is created only for a purpose of indicating the expectation of the editorial team about the formatting of the content submitted for consideration for publishing. In no way, the content in this document could be considered legal or authentic or related to any rules/regulations of the journal Editorial board. The headings of this document are followed by some introduction to the content covered under them. Authors should provide relevant headings to the content of the manuscript as indicated in the author guidelines such as 1. Introduction, 2. Methodology, 3. Results, 4. Discussion, 5. Conclusion, 6. Appendices and 7. References.

Units

Always use the International System units (SI) as primary units and English units (nonmetric units) as secondary units (in parentheses). Avoid combining SI and centimeter–gram–second system of units (CGS) such as current in amperes and magnetic field in oersteds. This often leads to confusion because equations do not balance dimensionally which is a variant of the metric system units. If you must use mixed units, clearly state the units for each quantity in an equation. Use zero before the decimal points.

The SI unit for magnetic field strength H is A/m. However, if you wish to use units of T, you should either refer to magnetic flux density B or magnetic field strength symbolized as $\mu_0 H$. Use the center dot to separate compound units, e.g., “A·m².”

Equations

Use symbol fonts in typing the equations. Label the equations (if any) consecutively and label the symbols used in the equations.

Clearly indicate the relevant positions of the equations in the manuscript.

Tables and figures

As KJMS will do the final formatting of your paper, you do not need to position figures and tables at the top and bottom of a page. Therefore, all figures, captions, and tables can be included at the end of the manuscript. Large figures and tables may be in landscape orientation. Place figure captions below the

figures; place table titles above the tables. If your figure has two parts, include the labels “(a)” and “(b)” as part of the artwork. Please verify that the figures and tables you mention in the text actually exist. **Please do not include captions as part of the figures. Do not put captions in “text boxes” linked to the figures. Do not put borders around the figures.** Use the complete “Figure” in the caption and text referring to the figure. Do not abbreviate “Figure” or “Table.” Tables and Figures are numbered with numerals.

Color printing of figures is available in the printed version of the journal, but the cost of the printed copy has to be borne by the author. Include a note with your final paper indicating that you request for a printed copy. **Authors should not use color unless it is necessary for the proper interpretation of their figures.**

Figure axis labels are often a source of confusion. Use words rather than symbols. As an example, write the quantity “Magnetization,” or “Magnetization M ,” not just “ M .” Put units in parentheses. Do not label axes only with units. For example, write “Magnetization (A/m)” or “Magnetization ($A \cdot m^{-1}$),” not just “A/m.” Do not label axes with a ratio of quantities and units. For example, write “Temperature (K),” not “Temperature/K.” Multipliers can be especially confusing. Write “Magnetization (kA/m)” or “Magnetization (10^3 A/m).” Do not write “Magnetization (A/m) \times 1000” because the reader would not know whether the top axis meant 16000 A/m or 0.016 A/m. Figure labels should be legible, approximately 10 point type in bold.

Tables

The table to be included in KJMS manuscripts should follow the color and border types as shown in following example. All tables should be captioned above them with proper descriptions/titles. Please note that the table should NOT be submitted as images. Tables should not break to next page. Whenever including long tables which are practically impossible to present in single page, you should place the header row in the beginning of the new page having part of the table.

Figures

Please do not embed your figures and tables in the text as the editorial board cannot extract them. (The figures and tables you insert in your document are only to help you gauge the size of your paper, for the convenience of the referees, and to make it easy for you to distribute preprints). Hence you should always submit high-resolution images in the manuscript.

The figure title has to appear at the bottom of the figure. All Figures including maps, photographs and plates shall be numbered in the relevant sequence and their title has to appear at the bottom.

Figures, graphics, plates, photographs and maps shall have approximately 300dpi with embedded fonts and have to be inserted in the relevant place of the text.

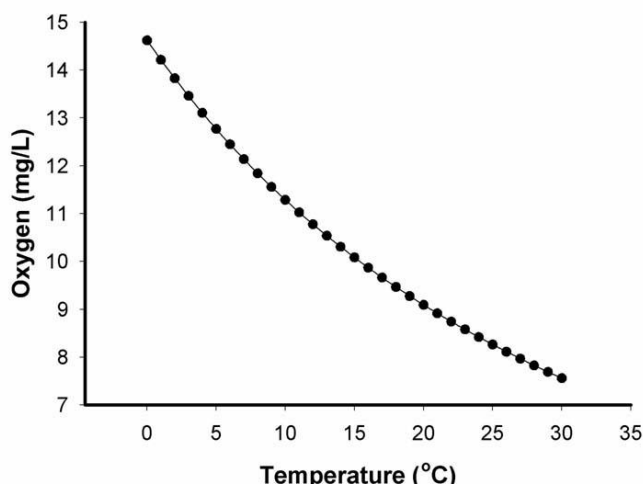


Figure 1: Solubility of Oxygen with temperature.

The authors should add only those the images in the manuscript which are required for illustration of a concept described in the manuscript. They should submit, on separate files, enlarged versions of the tables and figures that need to be included in the document. The figures should be properly referenced in the text of the manuscript wherever applicable.

You will have the greatest control over the appearance of your figures if you are able to prepare electronic image files. Vector images are always preferred for maintaining the best appearance while editing. If you do not have the required computer skills, just submit high-resolution images.

Abbreviations and acronyms

Define abbreviations and acronyms the first time they are used in the text, even after they have already been defined in the abstract. Abbreviations used in KJMS such as, SI, ac, and dc do not have to be defined. Abbreviations that incorporate periods should not have spaces: write “C.N.R.S.,” not “C. N. R. S.”.

Appendix

Appendices, if needed, appear before ‘References’.

3. RESULTS AND DISCUSSION

References and footnotes

KJMS document translator cannot handle automatic endnotes in *Word*; therefore, type the reference list at the end of the paper using the “Harvard References” style.

Number footnotes separately in superscripts (Insert | Footnote). Place the actual footnote at the bottom of the column in which it is cited; do not put footnotes in the reference list (endnotes). Use letters for table footnotes (see Table I). The Reference list shall follow Harvard style. The latest version of the Harvard style could be downloaded from the internet and some examples Harvard style are given under references in this template.

copyediting

Manuscripts recommended for inclusion are sent for copyediting. The Required change in formatting and settings of the manuscripts are done. The authors may

be asked for incorporating corrections/modifications as per the review comments and a final version need to be submitted. When you submit your final version, after your paper has been accepted, this should abide to the template formatting without fail. Send the papers electronically. The paper will be again distributed for reviews and editing by the Editor-in-Chief.

proofreading and publishing

Editor(s), Author(s), and specialized proofreaders are included in proofreading and finalizing the manuscript for inclusion in the volume. The Editor of the manuscript assigns the manuscript to a planned volume of KJMS after publishing it in Sri Lanka Journal Online (SLJOL). When the papers receive digital object identifiers (doi) via SLJOL the journal volume is uploaded to KDU website with the doi numbers imprinted.

The Print version is edited and published through a separate process following the e-publishing of the journal volume.
