The location is at the General Sir John Kotelawala Defence University, Ratmalana. Mainly the works to be carried out are the Supplying, Fabricating and Installation of Wall Cladding System and Glazed Curtain Walling System for 28.00m height five storied Auditorium Building of General Sir John Kotelawala Defence University at Ratmalana. Works as described in the Specifications, Drawings and BOQ, The Contractor shall design the entire structure to meet the requirements which are mentioned in the relevant Standard, Specifications, Drawings and BOQs. And the Contractor shall be fully responsible for the structural stability of the structure. Works are to be carried out with concurrent to the other constructions cordially. It has been expected a high quality finishing of works after completing the works. Initial design report shall be submitted by the bidder along with bid. The initial design report shall consist of design parameters, assumptions, references and the member sizes of the aluminum sections and the thickness of the glass. Design shall be carried out by a qualified structural Engineer having BSc Civil Engineering or equivalent qualifications + corporate membership of IESL + 5years experience in similar works after obtaining relevant qualifications. Relevant information of the design engineer shall be submitted along with the bid.

- 2. Bidding will be conducted through National Competitive Bidding Procedure.
- To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirement.
  - Bidder shall consider the requirement under the Public Contract Act No. 03 of 1987 and few important extraction of the Act as follows.
    - a. "Any person who acts as an agent or sub-agent, representative or nominee on behalf of any bidder shall register himself and such public contract in accordance with the section 10 and shall furnish to the registrar the particulars required to be furnished under section 6."
    - b. "Where any person is an agent, sub-agent, representative or nominee for or on behalf of a bidder, he shall first produce a certificate of his appointment as agent sub-agent, representative or nominee to the registrar before he registers himself and the public contract under this section"
    - c. Bidders are advised to present the payment receipt or registration certificate before purchasing the bidding document, according to the public contracts Act No 3 of 1987" if relevant.

Bidder should have Experience in successful completion of at least one project similar to the
scope and the cost of more than Rs. 40.00 million and the projects should have completed within
last five years. Documentary evidence (Completion Certificates) to prove the successful
completion of the project/s shall be provided with the Bid. This requirement will be considered as
an eligibility requirement and non-submission of requested documents will be considered as
major deviation and cause for the rejection of bid.

- Average annual value of related work performed in last Five years shall be not less than Rs. 50 million. Audited Statements of last 05 years should be submitted along the bid document.
- The minimum Amount of Liquid Assets or credit facilities, net of other contractual commitments
  and exclusive of any advance payments which may be under the contract, shall be not less than
  Rupees 80 million.
