 - a. "Any person who acts as an agent or sub-agent, representative or nominee on behalf of any bidder shall register himself and such public contract in accordance with the section 10 and shall furnish to the registrar the particulars required to be furnished under section 6."
 - b. "Where any person is an agent, sub-agent, representative or nominee for or on behalf of a bidder, he shall first produce a certificate of his appointment as agent sub-agent, representative or nominee to the registrar before he registers himself and the public contract under this section"
 - c. Bidders are advised to present the payment receipt or registration certificate before purchasing the bidding document, according to the public contracts Act No 3 of 1987" if relevant.

- The minimum Amount of Liquid Assets or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be under the contract, shall be not less than Rupees 20 million.
